GENERAL SECURITY ENTITLEMENT RELIABILITY

- At the eleventh hour, and following a strong advocacy campaign by the RGA and partners, the NSW government agreed to include the following in the Water Sharing Plans: Measures of entitlement reliability/yield; and a commitment to review measures to increase average annual general security allocations.
- The Drought of Record Bill was defeated in the NSW Parliament following persistent lobbying by the RGA and partners. If passed, the Bill would have resulted in less water being allocated to irrigators.
- The RGA and SunRice submission (see RGA website) to the Productivity
 Commission's National Water Reform review highlighted that water reform has had unintended and disproportionate impacts across the Basin, in particular resulting in diminishing general security allocations.
 The RGA and SunRice recommended three new principles be adopted to address these impacts.

The Murray Darling Basin
Authority released their 'Trends in
Use' report in response to the Rice
Industry commissioned 'RMCG
report'. This report found that
Southern Basin Irrigators have
been deprived of 375 gigalitres of
potential annual allocation over
the past seven years. This adds
significant weight to our calls for
changes to the allocation
framework.

• The Basin Ministerial Council released it's independent expert report regarding the deliverability of water to the Lower Murray region. The report highlights that much of this additional growth in water use below the Barmah Choke is being met by Inter-Valley trade water deliveries, in particular water from the Murrumbidgee. This report supports our calls for urgent action to manage this demand and the increasing impacts on upstream irrigators and the environment.

ALLOCATION ANNOUNCEMENTS IMPROVEMENT

The MDBA has committed to the RGA that it will improve communications about allocation of water between the States who benefit from River Murray resource.

WATER MARKETS

The ACCC is completing its inquiry into the Murray-Darling Basin water markets, with the final report to be released in February 2021. This report is expected to underpin the next decade of water market reform. The RGA ran an extensive consultation process with its water committee, members and SunRice to finalise our feedback and draft RGA and SunRice's joint submission (see RGA website). Pleasingly, the 544 page interim report highlighted many of our rice growers key concerns.

MURRAY DARLING BASIN PLAN

- Minister Pitt announced his plan to put "communities at the centre of the Murray–Darling Basin Plan", including a verbal commitment to no further buybacks or on-farm water recovery.
- The 450 GL socioeconomic test appears to be working, with minimal water recovery despite the program being open for over 12 months.
- The NSW Government is lobbying its Basin Water Minister colleagues for an extension of time for the SDL Projects, which offset the need for further buybacks. It is currently considering alternative and new projects, in order to address community concerns.

RGA WATER POLICY OBJECTIVES

The overarching water policy objective of the RGA is: "To maximise water availability (supply and access) and to mitigate the negative impacts of water reform for growers."

GENERAL SECURITY ENTITLEMENT RELIABILITY

Increase the reliability of general security water entitlements, recognising the fact that government policy has been a key driver of the erosion of entitlement reliability in the past.

ALLOCATION ANNOUNCEMENTS IMPROVEMENT

More timely, predictable and understandable allocation announcements.

WATER MARKETS

An open and transparent water market, which provides a level playing field for all participants, with minimal transaction risk and costs.

MURRAY DARLING BASIN PLAN

- No further Water Recovery.
- Delivery of the 605GL Water Recovery Offset projects without negative socio-economic impacts.
- Acknowledge and address the severe socioeconomic impacts for irrigation communities.

BITTERNS IN RICE

The Riverina Local Land Services Bittern friendly rice incentives project had some promising results in the 2019-20 rice season. The incentive sites attracted four times as many bitterns as the control sites, and successful breeding was recorded.

Despite it being another difficult season with drought and low water allocations, we found six growers who agreed to meet the criteria for a total of 279 hectares. We also monitored 308 hectares at control sites across seven additional rice farms.

The Riverina incentive program for bittern friendly rice growers has been fully subscribed for 2020-21. The RGA continue to look for funding opportunities to provide similar incentives for Murray rice growers.

This season 11 growers are growing bittern friendly rice over a total area of 980 hectares.
Three growers have committed to growing 100+ hectares each.

SunRice partnered with Matt Herring, Riverina LLS and our growers to produce a video titled "Saving the Bittern" that can be found on the SunRice Website.

Last season the RGA had a project with Murray Local Land Services to test our thermal drone technology in the Barmah Millewa Ramsar wetlands. A video of the project was promoted by Local Land Services for Science Week. The video can be found on the Murray Local Land Services YouTube Channel.



INNOVATE 4 WATER

The International Water Centre held an online conference aimed at bringing together "Water innovators" from around the world to "pitch" on their innovations or what problems need solving. Neil Bull pitched Building Social licence for the Australian rice industry. This presentation was watched by participants across the globe and receive positive feedback from participants.

LANDCARE

In the Murray the RGA hosts Erika Heffer as a Local Landcare Coordinator with funding support from NSW Landcare. Erika also has a contract to provide support services to the Murray LLS Regional Landcare Facilitator (RALF). In addition to supporting Landcare the project priorities include offering support to the RGA Environment Manager, assist with communications and help deliver RGA and Rice Extension activities.

WORK HEALTH SAFETY TASKFORCE

The Environmental Sustainability
Committee suggested that the RGA
establish a WHS taskforce comprised of
4 members of the PIA committee and the
Environment manager. The aim is to
promote and assist RGA members to
implement appropriate WHS policies
and procedures on farm.

NET EMISSIONS TARGET BY 2050

The RGA Environmental Sustainability Committee has been investigating the National Farmers Federation (NFF) Net Zero Emissions target with the aim to update the RGA's Climate and emissions policy. Critical to the adoption of this target is the ongoing reviews of new management practices and any suggested legislative requirements that could negatively impact the productivity and profitability of our rice farmers. There are a range of protections built into the NFF policy and these are seen as the minimum for the updated RGA policy.

NFF SUSTAINABLE DEVELOPMENT COMMITTEE

The key areas of discussion and policy development from this committee include: Net Zero emissions policy, EPBBC Act review, National Biodiversity Certification scheme and the Council of RDC's Climate Accelerator Program.

SUSTAINABLE RICE PLATFORM

The project was established with SunRice, Murray Local Land Services, Ricegrowers' Association of Australia, Riverina Local land Services with funding from the Australian Governments National Landcare Program in the 2018-19 rice season.

Since the beginning of the project 21 rice farming businesses have helped to develop the framework and ensured it represents rice growers interests.

The framework covers three sustainability pillars - Community, Quality and Innovation - all of which recognise that a healthy, thriving environment is our most valuable asset and the key to our shared success.

The framework will make use of and incorporate the coconvened United Nations and International Rice Research Institute Sustainable Rice Platform.

The planned data collection approach will be the basis for ongoing improvement. It will also guide the development of clear and relevant research priorities, to ensure the industry embraces the latest innovations and maintains its' world leading management practices.

2020 has been a year of great triumph for the Productivity & Industry Affairs (PIA) committee, ensuring government and industry investment and regulations aims to maximise the net profitability of growers, and maintain and improve cross-industry collaboration and coordination in the interests of growers and industry participants.

LEVY INCREASE

Future proofing the Rice Industry, a members driven initiative to increase grower levy payment from \$3 - \$6 per tonne. The rice industry plays a valuable role in Australian agriculture delivery export revenue, jobs and contributing significantly to the economic well-being of the regional communities in which it operates. The rate of the rice R&D levy has been increased to \$5.94 per tonne, for rice delivered on or after 1 July 2020.

Increasing rate of genetic gain in rice breeding will be achieved through:

- Continued implementation of molecular marker technology in mainstream rice breeding.
- · Evaluation of novel genetic resources
- Proficiency programs for quality laboratories
- Exploratory research in grain research

TRANSFORMATIONAL CHANGE

A scoping study is being funded by AgriFutures to understand how best to determine what transformational change will look like for the future of the Rice Programs.



As a result or a rice industry strategic planning meeting in December 2019 between AgriFutures, SunRice and the RGA, the following two outcomes were determined:

- 1. Investigating emerging technologies for transformational change in the Australian Rice Industry.
- 2. Scope breeding options to achieve targets of increasing the productivity of Reiziq (medium grain), developing a short grain that is resistant to lodging (Koshi quality) and developing a low GI quality grain.

The RGA will continue to work with the AgriFutures Rice Research and Development Advisory Panel and other industry stakeholders. Engaging with growers to understand R&D needs and get support for how this money will be applied and also determine what growers deem to be important for the future.

STRATEGIC RELATIONSHIPS

The RGA has worked hard over the last 12 months to maintain and develop new relationships with key industry bodies and members of the National Farmers Federation (NFF).

RGA has actively contributed to the Ag 2030 roadmap, it is a bold vision for the Ag industry to exceed \$100 billion in farm gate output by 2030. Collectively all of the RGA policy areas have had input into building this roadmap. Go to the National Farmers Federation website for more information.

BIOSECURITY

The RGA will focus on determining the best research and development outcomes in alignment with protecting the rice industry through: chemical, biological and cultural management practices. This will include planning to build an IPM program to combat the Fall Armyworm.

VESTING REVIEW

The RGA will continue to work with industry stakeholders to encourage the review of the current vesting and seal arrangements so that they reflect what's best for the future of the Rice Industry and RGA members.

CHEMICAL ACCESS

The RGA will continue to advocate for it's members to have access to chemicals which are critical to the rice industry whilst pursing avenues to ensure that an integrated pest management strategy will be developed.

On 17 December 2020 the SunRice Group released its half-year Financial Results for the period ended 31 October 2020 (1H FY2021), which were a strong set of results that demonstrated the resilience of the business in the face of a number of challenges.

The Group delivered Net Profit After Tax (NPAT) of \$12.1 million, in line with the previous corresponding period, and revenue of \$507 million, down 7% on 1H FY2020. The Group also confirmed that with planting concluded for the 2021 Riverina rice crop (CY21), it is estimating more than 450,000 paddy tonnes will be harvested early next year. The Group also confirmed that the estimated paddy price range of \$390-\$450 per tonne for Medium Grain Reiziq, announced in September 2020, remains in place at this stage. The RMB held its 92nd Annual Meeting on 18th November 2020. For those who were unable to attend, the key information follows. The 2018-19 export price premium and freight scale advantage have been verified as being \$25.8 million and \$4.39 million respectively. The 2019-20 export price premium is calculated to be \$27.5 million and the freight scale advantage \$2.01 million, but the independent verification for these later numbers has not yet been completed – once the results have been verified, they will be published on the RMB's website. These indicators are used to measure two key benefits that arise from the Sole and Exclusive Export Licence (SEEL) issued to SunRice.

COMING SOON: NEW AND IMPROVED SUNRICE GROWER PORTAL

Over the past 12 months SunRice Grower Services has been developing an entirely new grower portal, with significantly enhanced functionality, ease of use and valuable extra features. The portal has been designed in collaboration with a representative group of growers, and addresses the feedback around the limitations and functionality of the existing system.

Some of the new features include access to the portal from any device, simpler navigation, and the ability to create and submit contracts within the portal. One of the most exciting new additions is a near real-time dashboard of harvest progress by crop, showing planted area, moisture of latest delivery, weighted moisture of all deliveries, number of deliveries, total volume of all deliveries, progressive yields, whole grain yields (WGY%) once appraisals are completed, and detailed record of each delivery made.

All nominated individuals on grower entities will each receive their personalised login and transition to the new portal during February, in time for harvest.

The RMB's income is derived from the SEEL licence fee paid by SunRice, and a per tonne fee paid by Authorised Buyers. For the 2019/20 year, the Board decided to draw on its cash reserve rather than fully recover its costs through licensing fees, and so incurred a loss of \$201,000. While our reserve remains adequate to continue operations for the time being, it will need to be reinforced as soon as circumstances allow.

The RMB is tasked with encouraging a competitive domestic market for rice, and we now have 12 authorised buyers. We are very pleased to welcome the latest licence holder, Blue Fattoria Pty Ltd, managed by Mr John Scarrabelotti from the Lismore/Casino area. We wish John well in his future endeavours.

INSPIRING KIDS TO RETHINK AGRICULTURE AND TECHNOLOGY

Did you know there are satellites that monitor crop growth from space? Or a tomato farm in the desert of South Australia that's completely self-sufficient and sustainable?

The lucky kids from Murwillumbah heard all about these examples firsthand in a recent virtual session with National Farmers' Federation President Fiona Simson. The event comes off the back of the launch of Code Club Australia's recent lessons focused on the importance of agriculture and technology. These six coding lessons aim to inspire primary school aged kids to rethink agriculture, as a vocational pathway and a way to build a sustainable future.

DETERMINATIONS AND THE MARKET

VIC Murray determinations increased to 90% on 4 January, Goulburn was already at 100%. NSW Murray is currently on 43% and Murrumbidgee at 77% with the next update on 15 January. There has been some decent rainfall across the catchments in the last month however it has been close to average. See here and here for more.

The cooler temperatures and in-paddock rainfall has reduced water demand. In turn, this has seen prices in the allocation market slowly creep lower. Prices have dropped from ~\$140 to ~\$120 in the Goulburn. Above choke price came back from \$160 to \$150 while below choke prices have reduced from \$220 to around \$160 after 28GL was moved through the Murrumbidgee IVT on 5 January. Prices within the Murrumbidgee have remained steady around \$100.

'Connecting kids with where their food and fibre comes from is so important. Through the new Code Club ag projects, thousands of students around the country will get a taste of Aussie agriculture. Hopefully we'll see a new generation of ag innovators emerge from those classrooms!"

The Australian Digital Inclusion Index (ADII) shows that there is still a significant gap when it comes to digital equality in this country. Regional students have been disproportionately affected by Covid and this will have an ongoing effect on their educational outcomes. Code Club and the Telstra Foundation are committed to improving the inclusion rate of students in regional and remote areas of Australia.

These lessons showcase perspectives and experiences of these students in the hope that they will further engage with tech skills and see the relevance and centrality of tech on the farm. The updated MDBA Annual Operating Outlook indicates more water will be called through the Murrumbidgee and Goulburn IVT's to ensure supply in the lower Murray. This will see more water being transferred into the lower Murray, increasing supply and ultimately reducing prices.

OUTLOOK

With water moving through the IVT's into the lower Murray, prices are expected to soften further. It will be interesting to see where the floor in the below choke market is especially given determinations on the Vic side haven't yet reached 100% and may struggle to get there.

Irrigators in the Murray will look to carryover water into 2021-22 if they can source parking space. With the premiums being paid for parking space compared with the prevailing market prices of temporary water, many may consider forgoing carryover and entering the market in the new season to secure their requirements.
